OCCUPATIONS FLAGGED FOR CHANGES ON AUSTRALIA'S SKILLED OCCUPATION LISTS

The Government's upcoming update to Australia's Skilled Occupation List in July 2018 is likely to result in further changes to the occupations deemed eligible for a skilled visa. Below are the occupations currently being considered for removal or addition to the Short Term Skilled Occupation List (STSOL), Medium to Long Term Strategic Skills List (MLTSSL) and the Regional Occupations List (ROL), as flagged by the Department of Jobs and Small Businesses.

OCCUPATIONS FLAGGED FOR POSSIBLE REMOVAL FROM THE STSOL

17 occupations were flagged for removal from the STSOL, meaning these occupations may no longer be eligible for a skilled visa, including the Subclass 482 Visa.
